### Memorandum of Association / Stiftelsesdokument

The undersigned, Anderson Law LLP, a limited liability partnership registered in England & Wales (Registered Number OC363977), Jusmedico Law Firm Ltd. ApS, a limited liability company registered in Denmark (CVR. No. DK 3072 8106), and Subirats Advocats, a Spanish law firm comprising independent lawyers, have today resolved to form a non-profit Limited Liability Association under the name of:

#### BioLawEurope F.m.b.A.

on basis of the as Appendix I hereto proposed Articles-of-Association.

The share capital of the Association comprises EUR Nil (€ 0.00).

Individual members each pay an annual membership fee determined by the annual meeting, but not to exceed a limit to be recommended by the board of directors of the Association (the "Board"). For the year of incorporation, 2015, the membership fee for each individual member comprises EUR 100, whereas the membership fee for law firms as such comprise EUR 300.

The members of the association are not personally liable for any obligations of the Association.

The Board shall comprise between three (3) and five (5) directors, both numbers included. The Board members shall be elected among the Association members, including designates from members comprising law firms as such.

As from formation of the Association and until the first ordinary annual meeting of the Association in 2016, the directors shall be Mark Anderson (Anderson Law), chairman; Margot Subirats (Subirats), vice chairman & treasurer; and Jan Bjerrum Bach (Jusmedico), private member.

The accounting year of Association shall be from 01 January to 31 December. The first accounting year runs from formation on 27 January 2015 to 31 December 2015.

Individual-medlemmer betaler et årligt kontingent fastsat af generalforsamlingen indenfor rammerne af det af forenings bestyrelsen ("Bestyrelsen") foreslæde kontingent. I stiftelsesåret 2015 udgør medlemskontingentet for hvert individualmedlem EUR 100, medens kontingentet for hvert advokatfirma, der er medlem som sådant, udgør EUR 300.
